Writing Producer Amendment For Medicare Advantage Plans

This Writing Producer Amendment modifies the Ohio Insurance Producer Agreement (the “Producer Agreement”) between **Medical Mutual of Ohio** (“Medical Mutual”), **Business Distribution Solutions** (the Field Marketing Organization or “FMO”), and _____ (the “Writing Producer”) and applies only to Medical Mutual Medicare Advantage Plans (“MA Plans”).

Recitals

- A. The FMO and the Writing Producer have each previously entered into a Producer Agreement with Medical Mutual.
- B. The parties wish to amend the Producer Agreement as it applies to MA Plans.

Now, therefore, in consideration of the mutual promises contained herein, the parties agree as follows.

Provisions

- 1. The Writing Producer desires to work through the FMO for MA Plans.
- 2. The FMO will provide all sales and service support to Writing Producer for MA Plans.
- 3. The FMO will ensure that the Writing Producer is compliant with all Medical Mutual and Centers for Medicare and Medicaid Services (“CMS”) MA Plan requirements.
- 4. Any party may terminate this agreement upon thirty (30) days prior written notice to the other parties.
- 5. Neither the execution nor the termination of this Amendment shall have any effect on any other Writing Producer Agreements in effect between or among the parties.

6. This Amendment is hereby made a part of the Producer Agreement. Except as amended hereby, the Producer Agreement remains in full force and effect. The Producer Agreement consists of the Producer Agreement itself and this Amendment and any other amendments, addenda, schedules, or supplements and constitutes the entire agreement between the parties with respect to the subject matter thereof and supersedes any prior understandings to the extent they relate to such subject matter. Any capitalized term used herein not otherwise defined shall have the same meaning as in the Producer Agreement. This Amendment may be executed in multiple counterparts, and signature pages may be executed and exchanged by facsimile, PDF, or other electronic means, each of which shall be deemed to be an original and all of which taken together shall constitute a single instrument. The original of this Amendment may be stored electronically, and any printout or other output readable by sight that authentically reproduces the original of this Amendment may be used for any purpose just as if it were the original, including proof of the content of the original writing.

7. The effective date of this Writing Producer Amendment shall be the date it is signed by the Writing Producer.
